ARTICLES OF INCORPORATION

OF

THE VILLAGE OF INDIAN SPRINGS ASSOCIATION, INC.

We, the undersigned natural persons of the age of eighteen (18) years or more, at least two (2) of whom are citizens of the State of Texas, acting as incorporators of a corporation under the Texas Non-Profit Corporation Act, do hereby adopt the following Articles of Incorporation for such corporation:

ARTICLE ONE

NAME

The name of the corporation is THE VILLAGE OF INDIAN SPRINGS ASSOCIATION, INC.

ARTICLE TWO

NONPROFIT CORPORATION

The corporation is a nonprofit corporation.

ARTICLE THREE

DURATION

The period of its duration is perpetual.

ARTICLE FOUR

PURPOSES

The purposes for which the corporation is organized are:

- (a) The primary purpose is to promote the health, safety, common good and welfare of the residents of The Village of Indian Springs in The Woodlands, Texas, and to aid, benefit and promote

plans and recommendations relating to the physical, social or cultural development of The Woodlands, Texas.

(b) To have and exercise, subject to that certain Declaration of Covenants, Restrictions, Easements, Charges and Liens of The Woodlands recorded in the Real Property Records of Montgomery County, Texas under County Clerk File Nos. 8413451 and 8453474 and all other restrictions and covenants of similar form and substance imposed on property in Village of Indian Springs and recorded in the Real Property Records of Montgomery County, Texas, the By-Laws of The Woodlands Community Association, Inc., and the Bylaws of the Village of Indian Springs Association, Inc., all rights and powers conferred on nonprofit corporations under the laws of Texas, or which may hereinafter be conferred.

(c) To do all other acts necessary or expedient to the administration of the affairs and attainment of the purposes of this corporation.

(d) Notwithstanding any of the above statements of purposes and powers, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the primary purposes of this corporation.

This corporation is organized pursuant to the Texas Non-Profit Corporation Act and does not contemplate pecuniary gain or profit to the members thereof and is organized for non-profit purposes.

ARTICLE FIVE

INITIAL REGISTERED AGENT AND OFFICE

The corporation's initial registered agent for service of process shall be Joseph G. Solak. The street address of the initial registered agent's office shall be: 23 Rockridge Drive, The Woodlands, Texas 77381.

ARTICLE SIX
